#### GENERAL NOTICE

Based on Article 13 of the Swiss Federal Constitution and the data protection regulations of the Swiss Confederation (Data Protection Act, DSG), every person has the right to protection of their privacy as well as protection against misuse of their personal data. #### RIGHTS OF PERSONS CONCERNED

#### 3.1

##### RIGHT TO CONFIRMATION

Every data subject has the right to request confirmation from the website operator as to whether personal data concerning him or her is being processed. If you wish to exercise this right, you may, at any time, contact the Data Protection Officer.

#### 3.2

##### RIGHT TO INFORMATION

Any person affected by the processing of personal data has the right to obtain from the operator of this website, at any time and free of charge, information about the personal data stored about him or her and a copy of this information. Furthermore, information may be provided on the following, if applicable:

- the purposes of processing
- the categories of personal data processed
- the recipients to whom the personal data have been or will be disclosed
- if possible, the planned duration for which the personal data will be stored or, if this is not possible, the criteria for determining this duration

- the existence of a right to rectification or erasure of personal data concerning him or her or to
- restriction of processing by the controller or the right to object to such processing
- the existence of a right of appeal to a supervisory authority
- if the personal data are not collected from the data subject: All available information about the origin of the data

Furthermore, the data subject has the right to be informed whether personal data have been transferred to a third country or to an international organization. If this is the case, the data subject also has the right to obtain information about the appropriate safeguards in connection with the transfer.

If you wish to exercise this right to information, you can contact our data protection officer at any time.

### **3.3 RIGHT TO RECTIFICATION**

Every person affected by the processing of personal data has the right to demand that inaccurate personal data concerning him or her be corrected without delay. Furthermore, the data subject has the right, taking into account the purposes of the processing, to request that incomplete personal data be completed, including by means of a supplementary declaration.

If you wish to exercise this right of rectification, you may contact our data protection officer at any time.

### **3.4 RIGHT TO ERASURE (RIGHT TO BE FORGOTTEN).**

Any person concerned by the processing of personal data has the right to obtain from the controller of this website the erasure without delay of personal data concerning him or her, where one of the following grounds applies and insofar as the processing is no longer necessary:

- The personal data have been collected or otherwise processed for such purposes for which they are no longer necessary.
- The data subject revokes the consent on which the processing was based and there is no other legal basis for the processing
- The data subject objects to the processing on grounds relating to his or her particular situation, and there are no overriding legitimate grounds for the processing, or the data subject objects to the processing in the case of direct marketing and related profiling
- The personal data have been processed unlawfully
- The erasure of the personal data is necessary for compliance with a legal obligation under Union or Member State law to which the controller is subject
- The personal data has been collected in relation to information society services provided directly to a child

If one of the aforementioned reasons applies, and you would like to arrange for the deletion of personal data stored by the operator of this website, you can contact our data protection officer at any time. The data protection officer of this website will arrange for the deletion request to be complied with immediately.

### **3.5 RIGHT TO RESTRICTION OF PROCESSING**

Any person concerned by the processing of personal data has the right to obtain from the controller of this website the restriction of processing if one of the following conditions is met:

- The accuracy of the personal data is contested by the data subject, for a period enabling the controller to verify the accuracy of the personal data
- The processing is unlawful, the data subject objects to the erasure of the personal data and requests instead the restriction of the use of the personal data
- The controller does not need the personal data for the purposes of the processing for a longer period of time, but the data subject needs it for the assertion, exercise or defense of legal claims
- The data subject has objected to the processing on grounds relating to his or her particular situation, and it is not yet clear whether the controller's legitimate grounds override those of the data subject

If one of the above conditions is met, you may request the restriction of personal data stored by the operator of this website, you can contact our data protection officer at any time. The data protection officer of this website will arrange the restriction of the processing.

### **3.5 RIGHT TO DATA PORTABILITY**

Every person affected by the processing of personal data has the right to receive the personal data concerning him or her in a structured, common and machine-readable format. He or she also has the right to have this data transferred to another controller if the legal requirements are met. Furthermore, the data subject has the right to obtain that the personal data be transferred directly from one controller to another controller, insofar as this is technically feasible and insofar as this does not adversely affect the rights and freedoms of other persons.

In order to assert the right to data portability, you may at any time contact the data protection officer appointed by the operator of this website.

### **3.6 RIGHT TO OBJECT**

Any person concerned by the processing of personal data has the right to object, on grounds relating to his or her particular situation, at any time to processing of personal data concerning him or her.

The operator of this website shall no longer process the personal data in the event of the objection, unless we can demonstrate compelling legitimate grounds for the processing which override the interests, rights and freedoms of the data subject, or if the processing serves the purpose of asserting, exercising or defending legal claims.
